User rights:

GDPR

Echo School processes the personal data received directly from you, as data subjects, or indirectly, during the development of commercial/contractual relations and/or participation in the events, activities, conferences, workshops, seminars and demonstration sessions organized by us.

Personal data are collected either only with your consent/acceptance, if they are offered knowingly, willingly, on your own initiative, or at our request, for example, through one of the online forms

used, etc., by subscribing to newsletters, participation in promotions, raffles, contests, loyalty programs, promotional campaigns, etc.

If you do not agree with any of the terms of these terms and conditions, do not use our website or provide us with personal data.

In this sense, Echo School will process, among others, the following personal data: name and surname, telephone, home address, e-mail, profession, place of work, identity card series and number, passport series, numerical code personal, school completed, studies completed, etc.

When you purchase a service provided by Echo School, as well as when you participate in events, activities, conferences, workshops, seminars, demonstration sessions, etc. organized by Echo School, we will collect personal data in connection with the provision of those services. At the same time, as a potential client, we will collect personal data (image, data processed through video surveillance systems, etc.) in order to fulfill legal obligations and carry out current activity.

We collect this personal data for the following purposes:

- organization and support of courses and training programs and professional training or organization of other know-how transmission sessions;
- running the commercial/contractual activity;
- invoicing the value of the services;
- marketing, promotion, advertising, contests, raffles, loyalty programs, including the transmission of general or personalized commercial offers;
- development and improvement of services (eg: feedback forms);
- managing relations with clients; commercial communication with clients through any means of communication (eg: course participation reminder);
- fulfilling legal obligations (eg: issuing invoices);
- communication with public or public interest bodies/authorities/institutions;
- audit and control/supervision activities;
- archiving, statistical purposes;
- debt collection/overdue debt recovery;
- resolving disputes and litigation, enforcing court, arbitration decisions, court orders, etc.
